

# Christ's College/Dallas Baptist University (DBU) Joint Masters Program

## 基督書院/美國達拉斯浸信會大學 企管碩士進修計劃

### I. Introduction: 引言

基督書院與美國德州 Dallas Baptist University 美南前 10 名校(2009 美國在台協會文案)合作開設企管碩士課程，畢業總授學分數達 39 學分以上，部分課程將會在基督書院開設，其餘將在美國 DBU 修課，並於課程完成時授予台灣教育部認可之 MBA 學位。本計劃已於主後 2000 年秋季班開始招生，首屆學生於 2001 年 7 月赴 DBU 參加課程。迄今已有近百位 MBA 校友在世界各處服務。

Christ's College, Taipei, Taiwan and Dallas Baptist University, Dallas, Texas, USA cooperate, on a college to college basis, to open a 39 Credit Hour Masters of Business Administration program with significant program components at both schools and the sharing of resources to make the program a success. Half of the course will be offered at Christ's College and the other half at Dallas Baptist University with Dallas Baptist University issuing the MBA degree upon the completion of all program .

### II. Purpose and Need: 企管碩士班 (MBA) 簡介

為因應企業全球化之趨勢，以及提昇校友與台灣經理人管理之需，本院於主後 2000 年秋季開始，與美國知名百年以上歷史之基督教教會大學企業管理研究所合作，以基督書院校友及台灣學生對象而開辦之企管碩士班。課程內容均以美國企管碩士共通課程為主要依循，大部分課程均以英語上課。為減輕學員經濟負擔，特規劃部分課程在本院授課，並禮聘多位學有專精之基督徒教授擔任企管基要學科之教師。其餘學科在美國大學研習。學業完成後由美國 DBU 頒授教育部認可之企業管理碩士學位文憑 (MBA)。

- ◇ Should Christ's College graduates need opportunities for further study, especially in programs leading to a degree that recognized by the Taiwan government? This program will meet this need.
- ◇ Some Christ's College graduates lack the financial resources necessary to pursue full time graduate programs in the USA. By taking half of the credits in Taiwan students in this program will realize a considerable saving in comparison to full time graduate study in the USA.
- ◇ Masters programs in Business taught from a Christian Perspective are rare to nonexistent in Taiwan. This program would be taught by Christian professors with terminal degree (PH.D/DBA) thereby advancing the cause of Christian Higher Education in Taiwan.

### III. About Dallas Baptist University 美國達拉斯浸信會大學簡介

DBU 於 1898 年成立於美國德州。其創校宗旨為提供以基督為中心的資優高等教育，專精於商業訓練、藝術及科學。大學部與研究所並進，為了要培養學生能將專業與信仰合而為一的基督僕人領袖。DBU 是美南大學認證組織所認證之大學 (亦為我國教育部所承認)。2008 年之學生數已超過 6,000 人。

Dallas Baptist University is a Christian University established in Texas 1898. The Mission Statement of the university is:

'The purpose of Dallas Baptist University is to provide Christ-centered quality higher education in the

arts, sciences, and professional studies at both the undergraduate and graduate levels to traditional age and adult students in order to produce servant leaders who have the ability to integrate faith and learning through their respective callings.’

Dallas Baptist University is accredited by the Commission on Colleges of the Southern Association of Colleges and Schools. The enrollment of the University reaches a record 6,000 students in 2008. The university’s commitment to providing quality Christian higher education through the integration of faith and learning gives direction and purpose to the entire educational enterprise.

#### IV. Program Entrance Requirement: 入學資格

1. 國內外大學英文或管理相關科系畢業生。
2. 在校平均成績 (GPA3.0) 以上。
3. 合宜的 GMAT 分數 (可於入學後再考)。
4. 基礎大學管理或英文課程學分。
5. 托福成績 450 分以上。
6. IELTS 6 以上

1. A bachelor’s degree. (The programs will open only to Christ’s College graduates in the first few years until our initial Purposes being fulfilled.)
2. A grade point average of 3.0 or higher on a 4.0 scale for all previous coursework.
3. Satisfactory GMAT scores.
4. Appropriate undergraduate course work in Business Administration or English.
5. A TOEFL score of 450 or higher.
6. IELTS 6 or higher

#### V. The MBA Program Requirements and Schedule 課程計劃

The MBA program requires 8 prerequisite courses for all MBA applicants. The courses can be waived if the applicants have taken the equivalent courses in Christ’s College Business Administration program.
